Membership Renewal

The renewal date was January 1. The membership fee is \$50 if your membership is not prorated because you joined sometime in the middle of the year 2019. Lawler House News

We were informed just before Christmas that the Agency that now owns the Lawler House is being forced by the State to place the building up for sale on January 1.

Doug Cooper, JoRené Danel and Dennis Ariza had a meeting with Greg Folsom, Suisun City's City Manager on January 9, 2020.

We discussed the sale of the Lawler House and the possibility of its purchase by the FSVAA.

The cost would be between \$100,00 and \$150,000. As most of you know the roof leaks,

the furnace, and air conditioner are also out of service and need to be replaced.

On January 16 Dennis Ariza had a discussion with the California Register of Historical Resources, Jay Correa Historian III.

He informed Dennis that the State no longer is offering grants to private groups to purchase historic buildings.

On Monday, January 20, the FSVAA held a special Board Meeting and during the meeting it was decided to abandon the idea to purchase and restore the building.

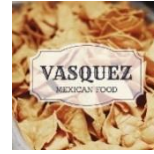
